### President's Report (Caryl Vaughan)

## Vice President's Report (Xavier Villarreal)

### Secretary's Report (Phara Rodrigue)

### Treasurer's Report (Tony Poleo)

### Architectural Review Committee (Forrester Cox)

- Porticos: approximately 25 homes have porticos that are costly to repair. Architectural committee will research options for repair or removal.
- It was suggestion that the By-laws be reviewed and possibly updated because some owner have made changes that were not submitted and approved by the ARC. Recommended that notices be distributed to all owners reminding of the requirement to have visible outdoor changes submitted and approved by the ARC.
- Marie Johnson will have an attorney review our By-laws to determine the authority to enforce them.
- Tony Poleo will provide the board with the contact information for an association entity that may be a resource for updating our By-Laws.
- Someone asked who is responsible for the upkeep of the mailboxes. Xavier will contact the local post office.
